Roll call was taken. 21 22 **NEW BUSINESS –** 23 Communities of Coastal Range - Comparison of Marinas: Marinas are regulated/governed by both the 24 state and federal governments. Several examples were passed around to review. An email will be sent to 25 each member with electronic addresses. It was also suggested to take a look at Astoria's redevelopment of their waterfront and public space. Christine suggested looking at a "Project for Public Spaces." 26 27 Committee Input – 28 In the course of the discussion many ideas and thoughts were brought forward. Some of those ideas are: 29 - Desire to keep boundaries open 30 - Pavilions 31 - Salvage old boats. Dry dock for rental as an overnight stay. 32 - Trollev 33 - Appropriate resources available for fishing, piers and access being one. 34 - Revitalization 35 OLD BUSINESS/UPDATES -36 Randy gave a brief recap to bring committee members up to speed. Randy also read from the Parks 37 38 Master Plan, which was adopted in 2012, section 5.5 Special Use Area Development Guidelines. This 39 lays out some of the guidelines to follow for development of assets. With gathering information from 40 individual input to surveys, Randy has engaged Greenworks from the Portland area and who has also 41 done our streetscapes, to do a rendering. This will then go to City Council for input. The final process of 42 looking for grants will take approximately seven to eight months to get everything onboard and then the 43 process of looking for grants. It is challenging to find grants that will work with a commercial element 44 involved. 45 Randy also wanted to mention the thought to look at Eastside Boat Ramp, already a city asset, and develop a commercial/recreational rental slips etc. Tying two different facilities. 46 47 The Boardwalk/City Docks Master Plan will be done in phases. It could be 2 ½ years to execute entire 48 plan. We are at 60 percent of taking concepts to City Council 49
