15 **1. CALL TO ORDER / ROLL CALL / APPROVAL OF MINUTES: NO QUORUM**

17 **2. NEW BUSINESS**

18 All equipment in the NE portion of the room had been removed leaving newly found storage  
19 for the Pool staff as well as the Parks department.

20 New piping/plumbing has been mounted on the wall. Very clean and accessible. The pipes run  
21 to a closed surge tank over the vault type pit that exposes personnel to chemicals and all that  
22 goes with that. It required two people, one as a spotter. When the water comes out of the tank,  
23 the water is filtered using a chemical injection system and cleaned. The use of Ultraviolet light  
24 is used to treat bacteria. If there is any deficiency, chlorine will be added to the level required.  
25 Turnaround time is every three hours and the water recirculates in the early A.M.

26 The City should realize an annual savings estimated to be \$100,000 to \$150,000. The entire  
27 cost of the renovation is anticipated to be paid back to the City within two to two and one/half  
28 years.

33 The commissioners all were pleased with the work and impressed with the efficiency and the  
34 cost savings to come in the future.

38 **5. ADJOURNMENT**




