ISSUE Resolution 12-27 to accept the "Official Canvass of Votes" for City of Coos Bay Mayor and City Councilors for the 2012 General Election held November 6, 2012

BACKGROUND

Section 6.4 of the City of Coos Bay City Charter requires the results of all elections be made a matter of record in the Council minutes and that the official canvass as prepared by the Coos County Elections Department showing the votes for the election of the Mayor and City Council positions be accepted.

The November 6, 2012 election results were unofficially certified on November 7, 2012 by the Coos County Elections Office. On November 14, 2012 Certificates of Election were prepared for delivery to the newly elected officials in accordance with ORS 254.565 and 254.568. On November 20, 2012 oaths of office were administered to Mayor Crystal Shoji and Councilors Mark Daily and Gene Melton. The oath of office will be administered to Councilor Mike Vaughan at the December 4, 2012 meeting. On November 26, 2012 the City received the "Official Canvass of Votes" for the election as certified on November 20, 2012 and is an attachment to Resolution 12-27.



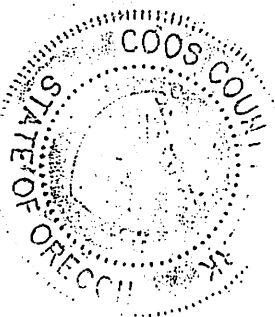

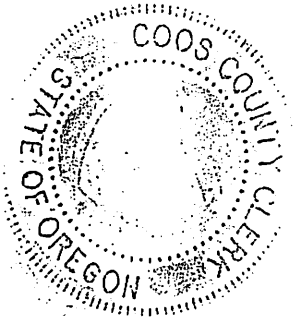

**Resolution 12-27**

**A RESOLUTION OF THE CITY OF COOS BAY, COOS COUNTY, OREGON ACCEPTING THE ELECTION RESULTS OF THE GENERAL ELECTION OF THE MAYOR AND THREE CITY COUNCILOR POSITIONS**

WHEREAS, the City Council of the City of Coos Bay called for an election on the 6<sup>th</sup> day of November 2012 for the purpose of election of the Mayor and three City Councilor positions; and

WHEREAS, it appearing to the City Council that the City Recorder gave notice thereof as required by the laws of the State of Oregon, and it further appearing that the County Clerk had prepared and arranged in the manner provided by law for the information on the ballot to be used in said election, and it further appearing that all of the requirements of the laws of the State of Oregon and of the Charter of the City of Coos Bay concerning said election were fully performed, and that said election was duly and legally held in said City; and

NOW, THEREFORE, BE IT RESOLVED, that the attached abstract of votes upon the election of the Mayor and City Councilor positions, it appearing that the measure received the number of votes in the respective precincts as set forth in the official abstract, be entered into the official records of the City as required by City Charter.

The foregoing resolution was duly adopted by the City of Coos Bay, Coos County, Oregon this 4<sup>th</sup> day of December 2012.
