- PLOT PLAN** showing location, dimension and type of ALL signs (proposed and existing), building and lot frontage along all street frontages, and the proposed sign's distance from the property lines, vehicular access and pedestrian walkways.
 - SKETCH OR PHOTO** of the advertising copy on the proposed sign.
 - STRUCTURAL ELEMENTS** of the sign including a dimensional diagram of the footing(s). The building inspector may also require wind load calculations and/or engineered design.
 - RIGHT OF WAY USE PERMIT APPLICATION** – Required if any portion of the sign projects over or is placed in the public right of way.

Per City of Coos Bay Resolution 17-03, a 5% Technology Fee will be assessed on all permit and plan review fees.

NOTICE: The issuance of a sign permit by the City does not ensure compliance with state requirements. You are encouraged to contact the State Highway Department before applying for a permit to install signs which face, project over or are located within a State Highway right of way.

This permit becomes null and void if work or construction authorized is not commenced within 180 days, or if construction or work is suspended or abandoned for a period of 180 days at any time after work is commenced.

The granting of a permit does not presume to give authority to violate or cancel the provisions of any other state or local law regulating construction or the performance of construction.
